

Santa Rosa County Citizen Corps K4SRC 2m Net Script

At ~1855 (5 minutes prior to Net start):

This is (***your call sign***) Santa Rosa County Florida Citizen Corps net will start in five minutes.

At 1900:

Is the frequency in use? **[UNKEY ~3-5 seconds]**

This is (**your call sign**) and this is the Santa Rosa County Florida Citizen Corps net. Citizen Corps includes both our ARES (Amateur Radio Emergency Service) & CERT (Community Emergency Response Team) program volunteers. 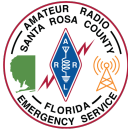
This net is to help keep you informed and an opportunity to exercise your skills and capabilities to support communications during activations in support of Santa Rosa County Emergency Management. These capabilities include (but are not limited to) the ability to operate equipment without commercial power; ability to communicate in a direct, concise manner; ability to precisely follow the directions of net control and the ability to pass traffic.

[Unkey]

This net meets Tuesday at 19:00 local time on the K4SRC repeater in Milton, FL operating on 146.700 with a minus offset and PL-tone of 100Hz, linked to the KO4SRC repeater in Munson, FL operating on 147.330 using a positive offset and DCS code of 023. In the event of a repeater failure, switch to the operable repeater. Outside the local area, you may use EchoLink K4SRC-R or WiresX 09422. This is a directed net. Please do not transmit unless requested to do so by the net control station. Our Citizen Corps Program Manager is Arc - W4CPD. Our ARES Emergency Coordinator is Jon – KM4QO and our CERT Captains are Matt, Ralph, Mike, and Ira. Any of our leadership volunteers will be glad to answer any questions or assist you in any way we can. Before we begin, do we have any announcements for the net?

[Acknowledge each station, ask if there are any other stations with announcements, then call each station having announcements in order.]

[Unkey]

The national traffic system is utilized to pass formal radiogram messages throughout the world via amateur radio. If you would like to learn more, please visit ARRL-NFL.ORG/NTS. Do we have a national traffic system (NTS) liaison station on the net? [Unkey]

Does anyone have any traffic to be passed into or out of our local area? [Unkey]

We will now move to the check-in portion of our net by area. When checking in, please respond by saying “This Is”, unkey your mic and pause to make sure you are not doubling, then state your callsign, first phonetically, then normally, your name, location, and advise if on emergency or commercial power. As an additional check-in, you may send a Winlink check-in form to NFL-SRCEOC.
